 - o We have 1 member who has taken advantage of this to date.
- Once you register online, you have to select what committee you are on. The list will be sent to the committee chairs so that they know who is on their committee post registration
- If members do not select a committee, Jeremy will send an email to those individuals with a list of the committees to ensure that they select one.
- Senior Directors need to go in and put in the system of who you have received checks from so far.
- Question came up to Jeremy- How life members can get involved in the free registration drawings for the conference. Discussion to the board.
 - o Discussion-Drawing for the free registration is held at the Spring JCEP meeting in March
 - Registration for the conference will be more expensive overall because we are adding lodging to registration fee
 - o We have been able to give away 2 free annual conference registrations

- Life Members are considered to be full fledged members and receive support from the administration. Some of the life members feel like they are not inclusive. Added carrot such as a new cabin for life members or drawing for free conference registration could be a possibility

- Committee's goal is to work on updating the bylaws this fall to reflect a more current version
- Inconsistency in wording, language, titles, policies, and rpocedures.
- Below is the brief proposal for the bylaws according to article 11, the board is able to make small changes for wording, providing clarity but would not affect the membership

Proposal summaries

1. Article 2, Section 1: Membership

a. Partner members description updated to reflect "partner" rather than "associate"

b. Update partner and memberships to reflect eligibility to receive an award, but not to be a lead author on the award proposal and the eligibility to attend the national meeting, but not receive financial support from the state association.

2. Article 2, Section 2: Dues

- a. Remove that the dues are ratified and voted upon by membership. Membership dues are set by the Board of Directors.
- b. Update Life Member dues to reflect the fees outlined in the membership section 1 (required to pay one-time dues, that is three time current amount of national dues, plus current GAE4-HA dues)
- c. Additional clarification of fiscal year occurring with term of officers, with change over occurring immediately following the annual state meeting.

3. Article 2, Section 10, A: Standing Committees

a. Update language to reflect Board of Directors rather than Trustees

- Amazed at how respected agents are in this country. We have the largest club membership in the country
- Only one of 5 states that does not use 4-H online
- We have some great things in this state. We have some fantastic resources but we have so much that so many other states do not have. All state leaders will be meeting in Atlanta for the national leadership meeting. They will all go to Rock Eagle for a day, to take them out of Atlanta and see how we are helping children.
- Board of Regents- each camp us will have to come up with a minors on campus policy. Arch is on the committee. This will change some things on what we do. 2 big things that will change:
 - Creating an inventory system on all that we do (any minors group on UGA campus) the inventory.
 Each county will need to put in a contact person if there is a problem with an event that happened in a particular county. Hopefully that will be relatively simple
 - How often will background checks need to be run- Every 3 years (Board of Regents) and UGA has not stated their frequency. Waiting to hear the final say. Currently UGA is paying for all background checks. Extension has some of the most background checks run. Averages about \$54 a background check
 - We have to retain Code of Conducts and Health Forms on every child, on every event until they are 21 years old. Because the child has until they are 21 years old to report abuse.
- Kids can come back to Project Achievement but in a different project area but in a different field (of the 4). All districts were notified at the updates this fall.
- Camp Jekyll is open! Things to address. First school will be there on February 1st.
- Swimming pool at Fortson is fixed. Gym is not usable yet but the plan is in hand to work on that in the next few weeks so that it is done by the summer
- Rock Eagle History Book is completed. The book took 9 ½ years to complete, 640 pages. Probably the most complete history of Rock Eagle, Environment Education program, Camping program, and Georgia 4-H history.
