Step 2: Middle of the page under "How do I Obtain a Private Pesticide Applicator License" (see below)

Click on **Georgia Professional Certifications Storefront**. *Cost of the test is \$25.00.* This has to be paid online.

How do I obtain a Private Pesticide Applicator license?

- *Step 1:* Purchase course access (cost is \$25.00) for the interactive Private Applicator training program through the **Georgia Professional Certifications storefront** on the UGA MarketPlace. Dr. Mickey Taylor (email: mickeyt@uga.edu or cell phone: 706-540-4108) will enroll students twice per day, midmorning and late afternoon, and send you an enrollment notice by email with your user name and temporary password (you will be required to reset your password when you login to gaprocerts.com for the first time).
- *Step 2:* Complete the new Private Applicator Training course on the Georgia Professional Certifications website, using the username and temporary password sent to you by Dr. Taylor. Follow the instructions carefully! You must pass the final test (a grade of 70 or higher) for each module in sequence (Module 1, then Module 2, followed by Module 3, and so on) before you will be allowed to proceed to the next module. You may retake the final test as many times as needed to achieve a passing grade. The time to complete the course will be approximately 4-5 hours for novice farmers.
- *Step 3:* When you have completed the training course, print the Certificate of Completion and take it with you to your county Extension agent. ([Find your County Office](#)).
- *Step 4:* Certify to your county Extension agent that you are engaged in the production of an agricultural, ornamental, or forestry commodity by completing the [Private Pesticide Applicator License Application](#) and complete the Verification of Lawful Presence if needed for forwarding by your county agent to the Georgia Department of Agriculture Pesticides office.
- *Step 5:* The GDA Pesticides office will review your application and, when approved, send it to the Licensing Division, who will print and issue your license (usually in 3-4 weeks).

Step 3: Click on the **Private Applicators** tab to purchase the test. Follow instructions.

Step 4: Print the **Certificate of Completion** and bring that along with the **notarized affidavit** to the Extension Office. We will get a copy of your **driver's license** and have you fill out the **application** and send that to the Department of Ag and they will send you the license.

We entered Oconee as our example in this case. Click on the **“Review Order”** button to go to the Review Order page.

Review your order carefully and when you are satisfied **click** on the **“Submit Order”** button.

This will bring up your Order Receipt, which you can print for your records.

A copy of your Order Receipt will also be sent to your email address. The following steps will occur automatically once you submit your order. Dr. Mickey Taylor will immediately receive a notification of your order, including the name you entered on the Payment Methods page and your email address. Dr. Taylor will enroll you and other students who also have ordered the Private Applicator Training Course approximately twice each workday, around 10:00 AM and 5:00 PM. 

Welcome to the Georgia Private Pesticide Applicator training course.

There are ten modules with each module corresponding to a chapter or chapters in the National Pesticide Applicator Certification Core Manual Second Edition from 2014. This course is "Interactive," which means you must carefully follow the on-screen instructions in order to move to the next slide. Examples of these instructions include "Click me first," "Next," "More," "Back," "Finished," "Click on each topic from top to bottom (or from left to right)," and several others.

Each module contains one or more quizzes to help you evaluate your understanding of the topic except for [Module 2 "Federal and State Pesticide Laws and Regulations,"](#) which has only a final test. Quizzes are not graded but each question, when submitted, will return a popup message to tell you whether you got the correct answer or not. All quizzes may be reviewed by you to see the correct answer for those questions that you missed. Quizzes do not count toward the final module test grade.

A score of 70% or better is required on each module's final test to successfully complete the module and be allowed to advance to the next module. You may retake each module's final test as many times as necessary to achieve a passing score. Once you have passed the module's test ("Result:" will have a green check mark beside it and under that will be the message "Congratulations, you passed.") close the module's window by clicking on the "x" in the upper right corner of the window. That will return you to the course page where you should see a blue check mark in the small box to the right of the module's topic title (for example check [Module 1 Pest Management](#) for the small box). Now go to the next module and click on its title. Click "Enter" on the information page that opens and that will open a new window to begin the next module.

If you wish to go through the entire module again to study the information more closely, simply close the module window, and then click on the module name on the course page. An information page will be displayed where you can see how many attempts you have made and your grade on each attempt. Click on the "Enter" button and a new window will open. There will be a dialogue box asking "Would you like to resume where you left off?" Simply click on the "No" button and you will begin the module from the first slide.

Once you have successfully completed all ten modules, you may select the link at the bottom of the page to print your certificate. Please take this certificate and appropriate photo identification to your County Extension Office to complete your application.
