





Using Pesticides Wisely (UPW) 2020: The University of Georgia (UGA) and Georgia Department of Agriculture (GDA) are awaiting a decision by the U.S. EPA regarding Georgia's 2020 dicamba training program. A label request requiring only applicators who were not trained in 2019 to be trained in 2020 was submitted to the EPA but the final decision regarding this request may not occur until March 4, 2020. In light of this decision time frame, two training programs (Plan A and Plan B) have been developed allowing Georgia to quickly respond to the EPA's decision. Plan A meeting schedule (Table 1) will be put in place if the U.S. EPA supports our label allowing the training of only dicamba applicators who were not trained during 2019 (or anyone wanting to be trained again). Plan B meeting schedule (Table 2) will be put in place if the decision requires all dicamba certified applicators to be trained for the 2020 season.

AUXIN TRAINING REQUIREMENTS: GEORGIA 2020

Auxin use in Georgia has been extremely successful. This success can be directly linked to the UPW training, industry support, cooperation between state and federal agencies and most importantly, the dedication of growers and producers to attend training and follow all label directions. We must continue this effort in order to make certain the auxin technologies remain a valuable tool available to growers and producers for many years to come.

Engenia, FeXapan, Tavium, XtendiMax

- 1. As mandated by federal labels, one must hold a private or commercial pesticide applicator license to purchase and use these restricted use herbicides. Use is limited to **ONLY** those persons holding a private or commercial applicator certification. It is no longer permissible for non-certified applicators to apply these products under the direct supervision of the certified applicator.
- 2. The University of Georgia (UGA) and Georgia Department of Agriculture (GDA) are awaiting a decision by the U.S. EPA regarding Georgia's 2020 dicamba training program. A label request allowing only applicators who were not trained in 2019 to be trained in 2020 was submitted to the EPA but the final decision regarding this request may not occur until March 4, 2020.
- 3. Industry applicator trainings are encouraged and beneficial; however, they <u>will not</u> fulfill Georgia's requirement for auxin training.
- 4. Each label requires certified applicators to document application information. Forms have been designed to help with this challenge and can be found at your local UGA Extension office, from the herbicide registrant, or at http://www.agr.georgia.gov/24c.aspx

Enlist Duo or Enlist One

In order to ensure applicators of Enlist Duo and Enlist One have access to the most current and up to date research and technical information, attendance at a UPW meeting is required. The training and schedule will follow the same approach as noted above for dicamba products. Therefore, as stated on the Enlist Duo and Enlist One 24c labels, "the producer, certified applicator, or person responsible for the application of Enlist Duo or Enlist One in Enlist cotton or soybean, in -crop (planting through harvest), must attend Using Pesticides Wisely training that is approved by the Georgia Department of Agriculture". This means if you are the producer, certified applicator or person responsible for the application, you must be trained (Plan B) or if you are a new applicator or have not previously been trained you must be trained (Plan A). The decision, Plan A or Plan B, will be made no later than March 4, 2020.

Documentation of UPW Training

Bring your pesticide license to the training. Attendee's names will be placed on a list posted to the Georgia Department of Agriculture's auxin website at http://www.agr.georgia.gov/24c.aspx. Please allow up to 21 days after the training date for names to be posted. This list will serve as the official training record as attendance verification.

Two hours of pesticide credit for private or commercial will be offered.

RSVP and Maximum Attendance: Everyone must RSVP at least 3 days prior to the meeting that they would like to attend. *It is possible, that in some locations, everyone may not be able to attend their ideal meeting time/location.* Max attendance is determined by the Fire Marshal.

NO MEAL: NO meal will be provided because of time constraints and the volume of people required to be trained.

Training Agenda: Using Pesticide Wisely (UPW) will last about 1 hr and 30 minutes.
