Survey of members showed overwhelming emphasis on helping with professional association and state meetings. Following recommendations were developed and presented to board for approval:

- \$10,000 will stay in Operating Account
- \$5,000 will support 2020 Meeting
- \$3,000 will support 2019 National Meeting
- \$4,548.55 will support \$1,000 to each district and 548.55 to State Staff
- \$10,000 will be invested to earn future interest
