APPLICATION:

All 4-H'ers in the 4th - 11th grades in the 2019 - 2020 school year are eligible to audition. 4-H'ers who have graduated from high school or will graduate in 2020 are ineligible to audition. Applications must be uploaded to the submission form by June 13, 2020 along with video links to be considered for the 2020-2021 Cast.

YOUR COMMITMENT:

- The cost per cast member is \$250.00 and must be paid by the first rehearsal weekend. Financial assistance is available.
- A show schedule will be provided and all 4-H'ers selected will be asked to sign a commitment form for the shows scheduled for the year.
- Full cast rehearsals will be held at Rock Eagle 4-H Center on July 31- August 2, 2020 and August 15-16, 2020. Selected participants are required to be at these rehearsals. There will also be a one-day band rehearsal (date TBD) prior to the full cast rehearsals in August.
- Travel arrangements to and from rehearsals and shows is the responsibility of the 4-H'er and not the responsibility of the county Extension staff.
